## II. Resolution to Amend the Bylaws

The bylaws of the Graduate and Professional Student Association of Washington State University (GPSA) Article III, Section 9, Subsection E: Permanent Committees will be amended to add the following paragraph:

- 1. Additional standing committees may be created by the Senate.
- 1. Any additional standing committee must be created with a specified duration that is not longer than the current session of the Senate.
- 2. Appointments to additional standing committees will follow the procedures defined in subsection A.

# Reasoning

The senate currently has the authority to create standing committees. [Constitution, Article VI, Section 2] However, the current standing committees are enumerated in the bylaws, and there is no provision allowing for the creation of additional committees. Therefore, the only way to create new standing committees is to amend the bylaws as to the specific committees or to specify the power to create committees not specified in the Bylaws. [RONR (11<sup>th</sup> ed.), p. 491, ll. 26-32]

The amendment enumerated above would create the ability for the senate to create additional standing committees and not conflict with the Bylaws. The caveat in subparagraph (i) is designed to discourage the creation of committees in this manner rather than through an amendment to the Bylaws. The second subparagraph is necessary because of the wording of subsection A. I will note that this is a band-aid solution, but it will allow for the timely creation of committees at the current meeting without being in violation of the bylaws. As it may head of another questions, please not that the current wording in the Bylaws [Article III, Section 9, subsection A] only gives the Executive Board the ability to create ad hoc (special committees). Additionally, as the senate must vote to approve the committee anyway, there is basically no difference between that and having the senate create the committee. (Note that this does not preclude the President from making motions relating to committees in his or her capacity as a voting member of the senate.)
