

 - Senate members to review their Committee Chair and the Senate Chair.
 - The evaluations are going to be used to help determine chair-of-the year awards. The same is also being done for Senate Members, in order to provide a quantitative way to evaluate Senator-of-the-year.
- New Business
 - o Bylaws Internal Affairs Committee
 - Ralph
 - Bylaws working group worked on the bylaws over the summer, which consisted of Jennifer Johnson, Anastasia
 Vishnevskaya, Kristen Johnson, Allison Fisher, Michael Craven, Andrew Gillreath-Brown.
 - Kristen
 - Updated for clarity, communication, and to take out contradictories.
 - Main Updates
 - a. VPLA position not an appointed position, but an elected one.
 - b. Service on the University and GPSA Committees:
 - Senators are required to serve on at least one (1)
 GPSA Committee, service on the WSU
 Committees is optional.
 - Executive Officers serve on at least two (2) University committees;
 - College Representatives serve on at least one
 (1) University committee.
 - c. GPSA Members Attendance Policies. These attendance policies are the same that the Senate voted on in October.
 - d. Better clarification of what the Elections procedures look like.
 - Former Special Elections section is replaced with Regular Nominations and Open Applications.
 - The logic behind these procedures stays the same as with Special Elections, despite it being called something different.
 - e. GPSA Affiliate RSO funding





- Clear outline of the procedures.
- The minimum of \$500 and maximum of \$2500 can be requested per year.
- f. Workshops for RSOs that have received funding.
- g. Sponsorships of the programs consistent with the GPSA mission.
- Motion to strike the old bylaws and approve the new bylaws.
 - Questions/Discussion
 - a. Concerns about VPLA being elected position.
 - b. President and Vice President should not be required to serve in GPSA before running for those positions.
 - c. Should not be a minimum of \$500 for RSO Affiliate Funding.
 - d. Article 7, Section 1 have to accept the election results.
 - This provision was changed in the most recent version of the bylaws, which is now Article 7, Section 1F. Therefore, this is no longer an issue.
 - e. Motion to strike RSO Funding sections from the new bylaws.
 - This would be with the intention that the IAC would look closer at RSO Funding in the bylaws, then would present a substitution at the beginning of the Spring semester.
 - Question: It is difficult to apply on a yearly basis. Some RSOs may need to apply on semester-basis, since some RSOs may reform at different points throughout the academic year.
 - From a logistical standpoint, tt is easier to just have 1 application period in order to allocate money for the year, rather than twice a year.
 - Motion to postpone Bylaw discussion until next semester.
 - Question: Need to move the bylaws forward, because bylaws are always a work in progress.
 These are supposed to be updated every couple of years. However, amendments can be made at anytime.

- Suggestion to have a forum where issues with the bylaws can be voiced. This would allow for everyone to have a discussion.
- Motion for the previous question (i.e., to vote on the motion to postpone bylaws vote).
- MOTION REJECTED (i.e., to tabling the bylaws to Spring)
- Question: Should we just approve the whole document, rather than taking out specifics?
 - It could be done either way, just depending on how much oversight the senate wants over the IAC for this amendment of RSO funding.
- Vote on the motion to amend the bylaws to strike RSO funding language from the new bylaws.
 - MOTION REJECTED
- MOTION: Strike current bylaws and replace with proposed new bylaws (V. 11.09.2019)
 - a. MOTION PASSES
- Motion to have the IAC committee produce new wording on RSO Funding in conjunction with the Budget Committee
 - MOTION PASSES

 - None were over \$1000.
 - Everyone who applied will get funding for Spring 2020.
 - The budget committee needs more time to deliberate the amounts each RSO will be awarded.

GPSA Office Hours During Break
