- 5:45 | Guest Speaker Penny Martinez, Pullman Veterans Coordinator, WSU Office of Veterans Affair
 - An update on the population of veterans in WSU with around 247 veterans from Pullman
 - Lot of Staff involved in Veterans Day Celebration
 - Various trainings are provided for veterans in WSU Campus
 - Veterans are provided with certain facilities
 - In case benefits are exhausted, WSU offers tuition fee waivers
- 6:00-6:05 Dialogue with Penny
 - Information on Veterans Suicide Rate and if actions are taken to prevent so? Response: Psychology department has a contract, so they keep track. We have limited Psychologists here in the area and that makes it difficult
 - Are there stigmas regarding the veterans that we should be aware of? Response: There are stigmas, but all are not true, and one has to be simply supportive.
 - Are there specific programs to recruit veterans? Response: New approaches are being worked upon as Washington has the 2nd highest population of Veterans in US.
- 6:10 | Guest Speaker **Bobbie Ryder**, President of Pullman Civic Trust
 - Colfax- Albion-Pullman Rail-Trail Opportunity Railbanking and trail building for multimodal transportation and economic vitality is on the way



- Pullman Civic Trust (PCT) is a non-profit volunteer organization of more than 700 community-minded citizens of the Palouse that has completed many projects like Bill Chipman Palouse Trail, Three-Forks Wayside, River Park waterfall and Pine Street Bridge & Plaza
- The issue is that PCC railway corridor has remained idle since 2006 Trestle between Colfax and Albion burned in 2006 and this section has remained idle for the last 14 years. Lack of traffic demand opens the door for railbanking and trail creation
- WSDOT agreeing to railbank requires legislative approval
- Railbanking opportunities: Saves WSDOT money when maintenance is done by a trail management group that procured funding from dues and donations, frees up valuable assets for use elsewhere, provides year-round transportation and preserves taxpayer investment
- Next Steps: Create railbanking entity, introduce legislation to railbanking, fund raising for trail building

- Are there any other examples of trails other than Palouse? Response: There are many like Palouse to Cascades State Park Trail, Levee Trail in Lewiston Idaho, Community of Concrete, Washington has an ongoing project.

- Is fund raising on hold given the current situation? Response: Yes, it is. Currently raising goodwill.
- How may we as a WSU community contribute to this? Is it by voting for it to be passed regarding funding? Response: Speak to President Schulz and convince him to be onboard as railbanking has to go through a federal process.
