 - Sam: Would you be handling graduate students' recruitment?
 - ✓ No, grad school does the recruitment on their own. My job mainly includes maintaining the alumni relations.
 - Sam: What are the most important initiatives your office is working on right now regarding COVID?
 - ✓ Reinforced programming and support structures for incoming undergrad and grad students and meeting their needs.
 - James: How can we maximize interactions between the students and the students' affairs?
 - ✓ All kinds of helps can be offered depending on the specific requirements.

 - ✓ Though the grad students can buy the membership at the same expense as the undergrads. But it's an elective fee.

 - ✓ Factors such as inflationary increase,

 - ✓ Want to make sure that the rent is fair, but we are not drastically undercutting the market.

 - ✓ For personal belongings, it's not viable.

 - ✓ There have been plans and ongoing discussions for developing housing at these places in future.
